Verbal requests or written requests (not through this form) for decommissioning, scrapping and/or movement of a relevant electronic gaming machine will not be entertained and will not be considered as notification to the Authority. Failure to complete and submit this Form to the Authority shall cause the relevant electronic gaming machine/s to remain to be considered as operational within the approved premises.
- If there are any changes in the information provided in this Form, it is the Applicant's responsibility to advise the Authority immediately. Failure to do so could result in suspension or revocation of the relevant license and, or authorisation.
- This notification does not exonerate the licensee from any obligations under the provisions of the Data Protection Act (Cap. 440 of the Laws of Malta). The designated Data Controller may inter alia have to make certain notifications and additional submissions to the Data Protection Commissioner in relation to the transfer of personal data.
- This list must be sent to the Authority at least ten (10) days prior to decommissioning, scrapping, or moving the equipment.
