- This Application Form is to be submitted to the Malta Gaming Authority (the ‘Authority’) by a representative of licensee by not later than thirty (30) days prior to the expiration of the current licence.

- All answers must be completed in English.
- Any Documents provided in other languages must have a signed English translation attached thereto and certified that it is a true copy and translation of any original.
- Use N/A in response to any question which is not applicable.
- If there is not enough space on this form for any particular answer kindly attach a sheet hereto and write the section number at the top of the sheet and your signature.
- The Authority reserves the right to request additional information.
- If there are any changes in the information provided in this Application Form, it is the licensee’s responsibility to advise the Authority as per regulation 12 of the Regulations by not later than five (5) days after the change has occurred. Failure to do so could result in suspension or cancellation of the certificate of approval.

Certification of Documents Note:
